1. BACKGROUND. PRESS, WIRE SERVICES TODAY REPORT ARREST IN LEOPOLDVILLE, CONGO, TWO SOV DIPLOMATS, BORIS FORCHIN, COUNSELLOR SOV EMB, YURI NYAKOTNYKH, PRESS ATTACHE, UPON RETURN FROM BRAZZAVILLE (CAPITAL FORMER FRENCH CONGO), WHEN INCrimINATING DOCUMENTS, PROVING SOV SUPPORT FOR CHRISTOPHE GBENYE, FOLLOWER OF LATE LUMUMBA, NOW TRYING FORM CONGO KILE GOVT IN BRAZZAVILLE, FOUND IN THEIR POSSESSION.
