1. INTERVIEW WITH [REDACTED] REVEALS FOLLOWING:

A. [REDACTED] TELEPHONED REVEREND DANIEL PASCU WHO PASTOR ROMANIAN BAPTIST CHURCH CLEVELAND ABOUT TEN DAYS AGO. STATED PURPOSE CALL WAS TO FIND OUT IF POSSIBLE ADDRESS OF BARBU, WHOM TIKHONOV KNOWS AND WISHES TO CONTACT. TIKHONOV SPOKE FLUENT ROMANIAN, STATED BORN AND RAISED KALORASH NEAR KISHINEV. IS SOV CITIZEN BUT CONSIDERS SELF ROMANIAN. INVITED PASCU ATTEND PERFORMANCE AND ATTEMPT MEET HIM AFTERWARDS. WHEN PASCU URGED CAUTION [REDACTED] REPLIED THAT RUSSIAN DANCERS IN GROUP WERE KNOCKING SELVES OUT MEET RUSSIAN ENIGMAS, SO FELT HAD RIGHT TO MEET "HIS OWN PEOPLE." SAID HE THOUGHT COMPANY WAS STOPPING IN DENMARK ON RETURN TRIP TO MOSCOW, AND MIGHT HAVE OPPORTUNITY CONTACT BARBU WHILE THERE. PASCU KNEW NOTHING OF BARBU BUT PROMISED TRY FIND OUT.

B. CONVERSATION GAVE NO OVER INDICATION DISSATISFACTION OR DESIRE DEFECT.

C. PASCU ATTENDED PERFORMANCE BUT WAS COMPLETELY UNABLE

CONTACT [REDACTED]. ENTIRE COMPANY WAS HEARD-AROUND BUSSES RIGHT AFTER PERFORMANCE AND LEFT TOWN. PASCU THEN TELEPHONED [REDACTED] AND ASKED THAT HE ATTEMPT CONTACT [REDACTED] WHEN COMPANY REACHED NEW YORK. MANUELA SENT MIHON BUTARIU WHO ALSO ROMANIAN EMIGRE TO WENTCHESTER SEKER BALLEK WAS PERFORMING TO ATTEMPT CONTACT. BUTARIU KINGS AND CORRESPONDS VITE BARRU, AND TOOK LETTERS TO SEND [REDACTED] HOWEVER, PUBLIC WAS NOT ALLOWED TO APPROACH DANCERS, AND CONTACT ATTEMPT FAILED.

B. THEREFORE, MANUELA WROTE HIS CLOSE FRIEND POPOVICI TO ATTEMPT CONTACT NEXT. PREHANS EXAGGERATED LIKELIHOOD DEFECTION DUE TO "INTUITIVE FEELING" THIS WHAT [REDACTED] HAS IN MIND. EVERYTHING BASED [REDACTED] PHONE CALL TO PASCU WHICH ONLY CONTACT TO DATE.

2. ABOVE INDICATES PROSPECTS LESS THEN ORIGINALLY HOPED BUT HQS FEELS CONTACT ATTEMPT USING ROMANIAN EMIGRE WELL WORTH WHILE. POA APPLIED FOR TO USE [REDACTED] THIS PURPOSE. CONSIDER BARRU UNSUITABLE FOR ANYTHING EXCEPT INTRO TO [REDACTED].

3. BUTARIU PROVIDED RECENT LETTER FROM BARRU IN ROMANIAN WHICH DISCUSSES HIS ARTISTIC SUCCESS, HAPPINESS IN NEW YORK, HOPE FOR A

4. SUGGEST [] ATTEMPT MEET [] CITING LATTER'S PHONE CALL TO PASCH AND FAILURE OF ATTEMPTS BY PASCH AND BUTARIU MEET HIM PERSONALLY. CAN SAY BUTARIU FORWARDED LETTERS WITH REQUEST [] FROM THEM TO []. BUTARIU REQUESTS RETURN THESE ITEMS IF POSSIBLE. INFO OBTAINED BY [] ON [] PERSONAL SITUATION AND ATTITUDES WOULD DETERMINE FUTURE COURSE.

5. IF SITUATION SEEMS FAVORABLE SUGGEST AIM FOR DEFECTION IN NUKI. CABLE HQC FOR ^G GUIDANCE ON RESETTLEMENT AND FINANCIAL TERMS.

6. IF NO MEET POSSIBLE SUGGEST [] WRITE NOTE TO [] IN ROMANIAN ENCLOSING BARBU LETTERS AND EXPLAINING PER PARA 4 ABOVE. ATTEMPT PLACE IN [] HOTEL ROOM, IF POSSIBLE TO DO SO WITH MINIMAL RISK COMPROMISE OR MISADVENTURE.

7. IF [] UNWILLING OR UNABLE COOPERATE REQUEST STATION ATTEMPT FIND ANOTHER SUITABLE ROMANIAN ENIGNE. -SPEL SITUATION
