1. NICKY SZULC STILL IN MADRID AS OF 17 FEB. SHE TOLD [QUCOMUMN/1] SHE HAS BEEN IN CUBA THREE TIME, LAST TIME DURING INTERNATIONAL WOMEN'S CONFERENCE. WHILE THERE SHE CLAIMED BE WORKING AS ADVISOR FOR MINREX COUNTER-INTELLIGENCE SECTION. SHE SAID CUBANS GAVE HER ACCESS TO ALL INFO THEY HAD ON CIA ACTIVITIES AROUND WORLD. SAID SHE WAS PAID SALARY AND HAD CAR AND CHAUFFEUR AT HER DISPOSAL.

2. SZULC ALSO TOLD [Q/1] SHE HAD WORKED VERY CLOSELY WITH AGEE ON PREPARATION HIS BOOK. SAID SHE AND WEISSMAN AND AGEE VERY ANGRY WITH JOHN MARKS FOR PUBLISHING HIS BOOK "HOW TO SPOT A SPOOK". THEY TOLD HIM THIS WOULD ONLY ALERT CIA TO CHANGE ITS TACTICS, BUT MARKS PUBLISHED BOOK ANYWAY AND THEY NOW CONSIDER HIM TRAITOR.
