## MEMORANDUM FOR THE RECORD

SUBJECT: London LNERGO Handling of Mr. Norbert Itkin

SHOTH by SMUPROOT) (the SHOTH equivalent of C/VH who also acts as JKLANCE liaison control officer) on 18 May 1970. SMUPROOT of asked whether an article which had appeared in the London Telegraph on 16 May to effect that Itkin was on a JKLANCE secret mission in Britain in 1965, was accurate. SMOTH expected to be questioned by the British FCO on this. Because I was unfamiliar with the background of the Itkin case, I agreed to ascertain the facts and come back to SMOTH with the answer.

- 2. Before sending my query to Headquarters (see 1613, I questioned the local Chief, LNERGO. He said he was surprised at the press assertions that Itkin had any connection with JKLANCE at the time he was in London in 1965. He said that he personally had handled Itkin here in connection with a criminal investigation. JAGUAR was at first not told about the local LNERGO/Itkin relationship, but did share the results of Itkin's collaboration. Subsequently, JAGUAR (SMIDOSE) was able to accurately guess the source of Itkin's information and/or the local Chief, LNERGO had told (JAGUAR) he was using Itkin.
- 3. The local Chief, LNERGO recalled that he had been led to believe by his own headquarters that there once had been a relationship between Itkin and JKLANCE but that that relationship had been terminated before Itkin came to London. The local Chief, LNERGO said that he had not known and was surprised at the inference in the press that JKLANCE and LNERGO had simultaneously, had relationships with Itkin as late as 1965.
- 4. The local Chief, LNERGO did not describe to me the nature of the investigations for which he used Itkin beyond the fact that they concerned criminal matters of interest to LNERGO and (JAGUAR.)
- 5. The local Chief, LNERGO permitted me to tell SMOTH that he had handled Itkin in London on a criminal matter about which JAGUAR had been advised.
