1. Proceedings are currently underway to eliminate SUBJECT from the U. S. Army on grounds of unsuitability under the provisions of AR 635-105. To substantiate a portion of the case against SUBJECT it may become necessary to show that during 1967 and 1968 HE was not in the employ of your agency in any manner. In this connection request you advise USAPSG if your agency objects to the release of the attached DA Form 341 (Agent Report), subject as above, dated 21 June 1968, to SUBJECT, HIS defense counsel, and the members of the board, subject to dissemination restrictions imposed by the fact that the report contains classified defense information.

- 2. Should your agency object to release of the particular information included in the cited report, a letter from your agency stating that SUBJECT was not in your employ, in any manner, while assigned to Supreme Headquarters, Allied Powers Europe, would be equally sufficient.
- 3. For your information, the board hearing at which this information is desired to be used will be closed to the public and the press.
