2. FOR HAVA: RE YOUR INQUIRY HAVA 3822 (IN 16162) TO DIR ONLY, WHEN REPLY TO PARA 1 ABOVE RECEIVED, SUGGEST YOU RELAY INFO HAVA 3739 (IN 13055), WHICH SENT MEXI AND DIR, FOR PASSING ARTIME, SINCE HE NOT IN MEXI SINCE 24 FEB AND WILL GO DIRECT FROM RIOD TO NEW YORK 31 MARCH PER REFS A AND B.
