GENERAL

At Washington, D. C.

On 15 November 1961, the reporting agent obtained from Headquarters two copies of a telegram written in Spanish and addressed to Daniel CARSWELL, Reclusorio Nacional Circulo 4, Quinto Piso No. 33, Nueva Gerona, Cuba. The above telegram was signed by James R. MURPHY.

At 1146 hours of the same day, the Reporting Agent sent the above telegram from the Western Union Office located in the Investment Building at 15th and K Streets, Northwest. At the same time, the Reporting Agent prepaid for a one hundred word reply.

A copy of the telegram sent, and a receipt for the expense of sending the telegram and prepaying a reply, are attached to this report.

No Government interest was shown in the above transaction.
