 HELD ON STAND-BY BASIS UNTIL KNOWN WHETHER OSTENSIBLY NORMAL  
 DEPARTURE FEASIBLE OR BLACK METHODS REQUIRED. WOULD APPRECIATE  
 YOUR VIEWS HOW THIS LIKELY AFFECT ANY OTHER U. S. GOVT EMPLOYEES  
 RESIDENT SAME BUILDING.
