Subject's spouse is a current Agency employee, GS-14, who EOD in 1952. N.D.

(CARVER, Ruth Hundley (Hughes)) ⁰⁶ - 0-73779 - CHR

⁰⁶ (Ruth Carver) is a former Agency employee who resigned in 1958 because of domestic responsibility. Mrs. (Carver's) spouse is a current Agency employee. N.D.

CARVER, George A., Jr. ⁰⁶ - 0-85677 - CHR

Subject's reference is a current GS-17 staff employee who EOD in 1953. N.D.

CONEIN, Lucien Emile - 0/C-5025 - CHR

Conein served in a military capacity with the Agency and its predecessors from 1943 to 1956. In 1961, Conein was hired as a Contract Type A employee, although there is an IRD "Noteworthy Information" flag sheet dated 2 October 1961 in his file. Mr. Conein's contract was terminated in May 1968. There was no definite reason given why his contract was not renewed but there is some indication in his file that he may have been retired on disability.

METHVEN, Stuart Eugene - 0-62107 - CHR

Subject's reference is a current GS-14 Agency employee who EOD in 1952. N.D.

⁰³ (PECK, Thomas B.) ⁰³ - 0-/C-42149 - CHR

⁰³ (Peck) is a current GS-14 Agency employee who EOD in 1950.

A polygraph in June 1953 indicated noteworthy results but in September 1955 (Peck) ⁰³ was again polygraphed but with favorable results.

ANALYST NOTE: There is an SRS Flag Sheet in Mr. (Peck;s) ⁰³ Covert file, dated 20 August 1957.

[redacted] ⁰³ - 0-20899 - CHR

[redacted] is a current GS-13 Staff employee who EOD in 1951. N.D.

(INGRAM, Carroll Everett) ⁰³ - 0-58444 - SR

Subject's reference, who may or may not be identical, is a current GS-13 Staff employee who EOD in 1951. There is a IRD "Noteworthy Information" sheet, dated 19 January 1955 in (Ingram's) ⁰³ file.

ANALYST NOTE: ⁰³ There is an SRS "Flag Sheet" in Mr. (Ingram's) ⁰³ file, dated 16 June 1954.
