On above date Joseph Murphy, Security Officer, DODS, advised that Subject is considering filing an appeal from the security disapproval dated 11/15/62 to his wife to accept employment with the [redacted] Mr. Murphy requested advice as to procedure in filing an appeal. I suggested that, if Subject had any justification not previously submitted to Security, a second request would be considered by this Branch, but that, if Subject was filing an appeal with no additional justification, the appeal should be submitted thru Chief, DODS, and should reflect the views of Tracy Barnes. Subject has discussed his request with Mr. Barnes and may want to contact someone in Security above the Branch level.
