MEMORANDUM FOR: Inspector General

SUBJECT : Senate Select Committee on Intelligence Operations  
(Maheu/Roselli, et al Matter)

1. Reference is made to a 9 June 1975 memorandum from the Ad Hoc Staff, Number 833-75, which contains six questions posed by the Senate Select Committee. With specific reference to questions numbered two and three of referenced memorandum, appropriate Office of Security files have been reviewed with the following results:

a. Question two: "What were Agency associations with the following who were involved in the break-in of  hotel room? Fred T. Harris, Valetti, Edward Dubois, Edward Dubois' firm."

A search of the Office of Security's indices failed to disclose any subject files identifiable with those individuals and/or firm listed above. In conducting the above search, the following variations in the names of "Fred T. Harris" and Valetti" were also searched--Frederick T. Harris, Arthur J. Balletti, and Arthur J. Valetti. Further, a review of the Office of Security files relating to Robert A. Maheu and Johnny Roselli failed to disclose any evidence that the Agency had any relationship or association with the above named individuals and/or firm.

b. Question three: "Was Walter Fitzpatrick employed by the Agency in the fall of 1960?"

A search of the Office of Security and Office of Personnel indices disclosed an Office of Security file in the name of Walter L. Fitzpatrick (374452596),

who is believed identical to the above named individual. A review of cited file disclosed no evidence that Walter L. Fitzpatrick had been employed by the Agency in the fall of 1960. The Office of Security file reflects that the first Agency interest in Walter L. Fitzpatrick occurred in February 1965 when he became of interest to the Central Cover Staff in connection with his employment as the Office Manager for Robert A. Mahen Associates in Washington, D.C. The Central Cover Staff interest in Walter L. Fitzpatrick centered on his being the ostensible supervisor of an Agency employee utilizing the cover of Robert A. Mahen Associates. The Central Cover Staff canceled their interest in Fitzpatrick in August 1968.

Walter L. Fitzpatrick became of interest to the Agency again circa January 1973 when the Domestic Contact Service requested the Office of Security to conduct security checks on Mr. Fitzpatrick. The results of the security checks were reported to the Domestic Contact Service on 11 July 1973; however, the file does not reflect the reason for the Domestic Contact Service request, nor whether Mr. Fitzpatrick was ever actually contacted or utilized by the Domestic Contact Service. With the exception of the above Agency interest, the Office of Security file does not reflect any other relationship or association between the Agency or Walter L. Fitzpatrick.

2. The information contained above in response to questions two and three of referenced memorandum was obtained solely from Office of Security files. It should be noted that the results of a 1967 investigation by the Inspector General into "plots to assassinate Fidel Castro," including numerous memoranda collected by the Inspector General during that investigation, may contain additional information not contained in the Office of Security files. It is believed that among the above information in the possession of the Inspector General are memoranda which were formerly held in the Office of the Director of Security, and which were given the Inspector General during the 1967

investigation. Further, it is understood that the information currently in the possession of the Inspector General regarding "plots to assassinate Fidel Castro" has previously been provided to the Senate Select Committee on Intelligence Operations.
