SECURITY VIOLATION **RYBAT** REPORT

DETAILS OF VIOLATION: 65-32

At 2015 hours on 19 April 1965 a YOBELT guard during a routine after-hours check discovered on a desk in room #222, building 23 a standard "burn bag" stapled closed and filled with trash classified Secret.

3. DESCRIPTION OF HOW VIOLATION OCCURRED:

At about 2010 hours on 19 April 1965 [Redacted] prepared to depart from work. He stapled closed his "burn bag" but was distracted and left it behind when he went out the door. [Redacted] had assumed Branch and Floor Security Check duties, so he is solely responsible.
