OUR FEELING IS THAT IF SUBJ CAN SUCCESSFULLY REENTER THE CP AND IS WILLING REMAIN IN PLACE AS PENETRATION AGENT FOR PERIOD OF AT LEAST TWO YEARS AFTER REINSTATEMENT, ⁰²DTPACKING IS PREPARED RECOMMEND TO CHIEF, KOBARK THAT SUBJ BE BROUGHT TO PBRIME UNDER PROCEDURE OUTLINED PARA 2B, REF C.

2. IF SUBJ NOT WILLING MEET ABOVE CONDITIONS, HQS NOT INCLINED GIVE SUBJ ANY ASSURANCE OF ODIYOKI PROTECTION AND/OR VISA.
