2. The name <sup>07</sup>(GUZMAN) is utilized by subject as an alias, however, his [redacted] 31 is [redacted] 06 furnished by this Agency.

3. Our file has no entries prior to April 1964 when subject was admitted under Special Procedures from Canada.
