ON 17 FEBRUARY 1965 FRANK FIORINI SAID THAT ORLANDO BOSCH AVILA, LEADER OF THE MOVIMIENTO INSURRECCIONAL DE RECUPERACION REVOLUCIONARIA (MIRR) INSURRECTIONAL MOVEMENT FOR REVOLUTIONARY RECOVERY) AGREED TO LET THE CUBAN PILOT FLY THE MISSION SCHEDULED FOR 16 FEBRUARY INSTEAD OF THE AMERICAN PILOT. (FIELD COMMENT: THE SAME SOURCE REPORTED THAT BOSCH PAD SCHEDULED AN AIR STRIKE AGAINST THE CITY OF HABANA FOR 16 FEBRUARY IN A B-25. AN AMERICAN PILOT WAS TO FLY THE AIRCRAFT BUT WAS TO BE ACCOMPANIED BY A CUBAN PILOT.) THE CUBAN PILOT HAS BEEN TRAINING IN THE 6-25

AND APPARENTLY IS EXPERIENCED ENOUGH TO MAKE THE TRIP TO CUBA. - 4. ACCORDING TO FIORINI, IF THE RAID HAD NOT TAKEN PLACE ALREADY, IT WOULD PROBABLY BE MADE WITHIN 24 HOURS.
- 5. FIELD DISSEM: CINCLANT, CINCSO, COMKWESTFOR, MIAMI REPS OF STATE, FBI, BORDER PATROL, CUSTOMS, ILNS, AND USCG.
