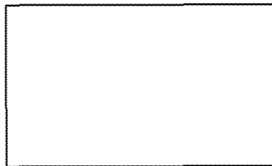
REFERENCES

1. Attached is a memorandum submitted by AMCLATTER-1 on 5 April 1961. A translation follows:

"I received a request from Dr. Jose R. ANDREU for assistance in obtaining a visa for his great-nephew, young Eladio DIAZ Salas, 17 years old, who is now in Jamaica and who wishes to come to this country to join the Army of Liberation. Young DIAZ Salas is in contact with Father ROPER. His address is: 3 Worblington Ave., Kingston 5, Jamaica; telephone 78-1787.

"Dr. ANDREU, former chief of the Partido Democrata in Cuba, father of Jose (Pepito) ANDREU who is in the camps, is an outstanding leader of the opposition to the Castro regime."
