APPRAISAL: A CUBAN EXILE WITH EXCELLENT CONTACTS IN THE MOVIMIENTO REVOLUCIONARIO DEL PUEBLO (MRP, REVOLUTIONARY MOVEMENT OF THE PEOPLE). HE HAS BEEN A RELIABLE REPORTER FOR MORE THAN A YEAR ON THE ACTIVITIES OF THIS ORGANIZATION AND ITS AFFILIATES AND ON EXILE POLITICAL DEVELOPMENTS IN GENERAL. THIS INFORMATION WAS OBTAINED FROM MAX LESNICK.

1. ON 23 AUGUST 1964 MAX LESNICK, EDITOR OF REPLICA, A NEWSPAPER PUBLISHED JOINTLY BY THE MRP - ALPHA 66 - SFNE ALLIANCE AND THE JUNTA REVOLUCIONARIA CUBANA (JURE, CUBAN REVOLUTIONARY JUNTA), SAID THAT ROGELIO CISNEROS DIAZ RESIGNED HIS MEMBERSHIP IN JURE ON 22 AUGUST AND THAT HE INTENDS TO GO TO PUERTO RICO TO LOOK FOR WORK. ACCORDING TO LESNICK, CISNEROS WROTE A LETTER OF RESIGNATION TO VARIOUS MEMBERS OF THE NATIONAL EXECUTIVE, EXPLAINING THAT SINCE THERE WAS DISSATISFACTION WITH HIS LEADERSHIP, HE THOUGHT IT WOULD BE BEST TO LEAVE THE ORGANIZATION. 2. LESNICK SAID THAT VARIOUS MEMBERS OF JURE ARE OPERATING IN SANTO DOMINGO. WHILE THE DOMINICAN GOVERNMENT IS NOT ALLOWING THE GROUP PERMANENT MOORAGE FACILITIES, JURE VESSELS WILL BE PERMITTED TO ENTER AND LEAVE THE PORTS WITHOUT ANY TROUBLE.

3. FIELD DISSEM: CINCLANT, CINESO, COMWESTFOR, MIAMI REPS STATE, FBI, I&NS, CUSTOMS, BORDER PATROL AND USCG. (ALSO SENT SANTO DOMINGO AND SAN JUAN.)
