1. In accordance with reference A request, on 8 September 1961 WAVE initiated contact with AMCORE-2 through Identity, informing him that henceforth we would be his point of contact for his activities.

2. The following questions have been raised by AMCORE-2 and Headquarters' clarification is requested:

- AMCORE-2 has requested an additional \$1000 to add to the \$2000 already passed to him per Reference B for publication of his book in the WAVE area. Is this total \$3000 payment in the nature of a one-time contribution or was it indicated to AMCORE-2 that detailed accountings would be necessary?
- AMCORE-2 requests information on the status of his book being published in Uruguay. Does Headquarters have any report on this matter?
- Can Headquarters supply additional information concerning its discussions with AMCORE-2 on the subject of his assets within PBRUMEN and types of action to be carried out. PM is investigating the claims made by AMCORE-2 re Alcio VERA Serafin and Oscar DIAZ. These were brought to WAVE by Domenick PANTLEONE.


