IT ALSO EMPHASIZES THE NEED FOR CONTINUED TACT AND EXTREME DISCRETION IN THEIR HANDLING. HQS FULLY COMMISERATES WITH STATION PROBLEM INVOLVING THESE INDIVIDUALS AND REALIZES THAT TIME SPENT IN THEIR HAND-HOLDING DETRACTS FROM MORE FRUITFUL AND VALID OPS ENDEAVORS.
