22 SEP 54 ROGELIO CISNEROS DIAZ TOLD AMRAZZ-1 THAT ON 19 SEPT HE HAD LONG CONVERSATION WITH BILL BOWDLER OF STATE DEPT. BOWDLER TOLD CISNEROS CUBAN ISSUE GOING TAKE LONG TIME SOLVE. HE FURTHER MENTIONED THAT PEOPLE AT STATE WHO HAD ALWAYS LIKED MANOLO RAY AND HAD TRUST IN HIM WERE DEEPLY DISAPPOINTED HIS FAILURE REACH CUBA BY 23 MAY.

2. ACCORDING CISNEROS, NUMBER OF NEWSMEN INCLUDING AL BURT OF MIAMI HERALD AND TED EDDIGER OF AP HAVE REQUESTED HIM MAKE STATEMENT AS TO WHY HE LEFT JURE. CISNEROS SAID HE WOULD NOT MAKE SUCH STATEMENT BECAUSE HE DID NOT WANT INTERFERE WITH ANY PLANS RAY MIGHT HAVE. CISNEROS, HIMSELF, EXPRESSED DEEP DISAPPOINTMENT WITH RAY'S FAILURE CARRY THROUGH WITH 23 MAY PLAN AND TOLD AMRAZZ-1 THAT RAY LED EVERYONE BELIEVE HE HAD SURE-FIRE WAY GETTING TO CUBA BUT EVIDENTLY DID NOT PLAN THINGS TOO WELL.
