LABELS WITH ANCORE-2'S ADDRESS WERE PASTED OVER HUNGARIAN ADDRESS, PRESUMABLY IN HAVANA POST OFFICE, AND RECEIVED BY ^{MANAGER OF WKUL} BUREAU IN NEW YORK. CONTENTS NOT SIGNIFICANT AND PACKAGE WILL BE RETURNED TO [BUREAU] FOR FORWARDING TO ANCORE-2. MQS INTERESTED WHETHER PACKAGES RE-DIRECTED SPONTANEOUSLY BY GOVT EMPLOYEES WHO HAD HEARD ANCORE-2'S BROADCASTS OR ANCORE-2 HAS ARRANGEMENT WITH CONTACT IN CUBA. SUGGEST WILLIMSON TEL ANCORE-2 HE UNDERSTAND A-2 MAY HAVE RECEIVED DIVERTED MAIL AND OBTAIN DETAILS ANY ARRANGEMENTS. IMPORTANT THAT A-2 NOT MAKE SUCH REQUESTS BY RADIO AT THIS TIME.
