- APPROXIMATELY 3 WEEKS AGO WE LEARNED VIA ⁰²RGACTRESS THAT EUSEBIO MUJAL WAS ABOUT TO ORGANIZE A FRENTE SINDICAL DEMOCRATICO AND THAT ACCORDING TO ⁰²RGACTRESS SOURCES AMHAWK WAS INVOLVED IN THIS. PARLETT QUESTIONED AMHAWK AND AMHAWK ON THIS PARTICULAR FRENTE AND BOTH EXPRESSED COMPLETE IGNORANCE.
- ¹⁵ [REDACTED] NOW ADVISES THAT ALBERTO ALVAREZ, FORMER CUBAN FOREIGN MINISTER, CURRENTLY RESIDING COSTA RICA, HAS PARTICIPATED FORMATION ABOVE-NAMED FRENTE WHEN HE WAS VISITING STATES IN MAY.
