FOLLOWING IS SUMMARY DEVELOPMENTS ON EVACUATION MARCOS DIAZ LANZ:

1. HERTON TRAVELED HABANA-TAMPA AND RETURN 20-21 JULY AND REPORTED  
AMCOO AGREED INFILTRATE SUBJECT 25 JULY. ARRANGEMENTS LAID ON WITH COURAGE  
ON BASIS PATRICK I, KARENEY WILL MEET BOAT TAMPA EARLY 27 JULY. COURAGE  
WANT EDUIMP ASSISTANCE IN MIAMI NOT NECESSARY AND F. ERNESTO T. BY NOT MADE  
WITTING.

2. [redacted] <sup>084</sup> AND [redacted] <sup>1084</sup> CONTACTED SUBJECT NIGHT 19 JULY AND REQUESTED  
TO STATION HE IN GOOD SHAPE BUT EXTREMELY NERVOUS AND SCARED. CONTACT  
ARRANGEMENTS WERE SET UP BY [redacted] <sup>084</sup> WITH [redacted] <sup>084</sup> FOR TRANSFER  
SUBJECT TO EMERGENCY (A. CLAYTON) WHO WILL TAKE HIM TO STATION SAFEHOUSE  
EVENING 23 JULY. AT STATION'S REQUEST SUBJECT SPECIALIZES ON DOCUMENTATION  
AND DISGUISE ETD WASHINGTON FOR HABANA 22 JULY AND JOIN TAMPA MIAMI EARLY  
MORNING 23 JULY. TAMPA WILL CARRY DOCS AND KIT MIAMI-HABANA. STATION WOULD  
DELIVER ACCESS BY FOR SECURE TRANSFER SAFEHOUSE TO BOAT.

3. <sup>03</sup>[BYERS] AND <sup>03</sup>[WILLIAMS] ALSO REPORTED AFTER 19 JULY CONTACT THAT SUBJECT CONCERNED OVER SAFETY WIFE AND TWO DAUGHTERS AND WILLING SEND THEM HERE BUT HAD NO FUNDS. HE UPSET SHE REFUSED PBPRIE VISA. STATION REPORTED WHEN SHE APPLIED FOR TOURIST VISA 8 JULY SHE WAS REFUSED BECAUSE OF SUBJECT'S "POLITICAL EXILE STATUS" (CONCLUDES UNWARE SUBJECT STILL IN CUBA) AND "INSUFFICIENT GUARANTEE" SHE WOULD RETURN CUBA AND NOT SEEK POLITICAL ASYLUM PBPRIE. STATION BELIEVES BEST WAY ASSIST FAMILY IS FOR RUBARK TO INTERCEDE NOW AT HCS FOR ISSUANCE PBPRIE VISA IN HABANA. HOWEVER, HCS BELIEVES PREFERABLE FAMILY GO MEXI AND HCS ATTEMPT OBTAIN ISSUANCE PBPRIE VISA IN MEXI AFTER SUBJECT'S ARRIVAL PBPRIE. HCS CABLED STATION MORNING 22 JULY IT BELIEVED PREFERABLE FAMILY GO MEXI BUT WOULD GIVE BETTER ANSWER SOMETIME.

4. HCS BELIEVES IT NECESSARY FOR SUBJECT'S SECURE EVACUATION THAT HE BE ASSURED PRIOR HIS EMERGATION 25 JULY THAT FUNDS AVAILABLE ASSIST HIS FAMILY GO MEXI. IF CASH ON HAND, HCS PLANS CALL STATION LATE 23 JULY AUTHORIZING FOR OF OF FUNDS (ESTIMATED 10,000) FOR FAMILY TRAVEL AND SUBSEQUENT VISA FEES.
