1. OLIEB MET AMHAWK EVENING 13 APRIL. HE SAID THAT PURPOSE IN HIS MIND OF TRIP TO PBPRIME WAS TO DISCUSS WITH SOMEONE WHO COULD SPEAK FOR ODYOKE HIS VIEWS ON THE CUBAN SITUATION AND TO DETERMINE WHETHER THERE WAS GENERAL AGREEMENT BETWEEN THEM AS TO ULTIMATE GOALS, ETC. FOLLOWING THIS HE WAS PREPARED SIT DOWN WITH REPS OF OTHER CUBAN GROUPS AND ENDEAVOR SPEIJ. OUT AND AGREE TO A PROGRAM AND COURSE OF ACTION. CONSEQUENTLY HE IS NOT KEEN ON A PRIOR MEETING WITH AMHAIL AS WE

2. OLIEN EXPLAINED TO AMHAWK THAT SO FAR AS PBPRIME THINKING WAS CONCERNED HE HAS ALREADY RECEIVED (SEE REF B) AGREEMENT IN PRINCIPLE AND SO FAR AS MEETING WITH AMWAIL WAS CONCERNED IT HAS ONLY LIMITED PURPOSE OF ENDEAVORING OBTAIN SUPPORT OF FIGUERES FOR EVENTUAL ESTABLISHMENT OF LOCALE FOR JUNTA.

3. IT SOON BECAME APPARENT WHAT EATING AMHAWK. SUBSEQUENT TO OUR LAST MEETING (REF A) HE HAD BEEN VISITED BY ANPALM-4 WHO SAID HE HAD ATTENDED MEETING IN PBPRIME AND THEY HAD BEEN "EXPECTING" AMHAWK AND THAT AMWAIL WANTED AMHAWK COME PBPRIME SOONEST. ARRIVAL IN PEPRIME O/A 24 APR AND METHOD APPROACH TO FIGUERES BE
WORKED OUT THERE BETWEEN THEM. THIS WILL HAVE MERIT OF PROVIDING
KJBARK CONTACTS OPPORTUNITY ORIENT AND REASSURE AMHAWK WHO
APPARENTLY SUFFERING FROM CERTAIN AMOUNT STAGE FRIGHT AND POSSIBLE
MISGIVINGS RE BASIC PLANNING. AMHAWK WOULD PREFER HIS ARRIVAL
