1. Reference is made to the request dated 12 July 1962, subject as above, whose name you desired checked against the files of this office. The files contain the following information concerning the subject of your request.

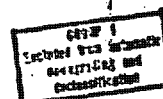
2. In July 1959, DIAZ was exfiltrated to the United States with the help of this Agency. A debriefing report dated 29 July 1959, Tampa, Florida, made following Subject's escape from Cuba gave the following biographical information:

Subject was born in 1928 to Pedro Luis DIAZ Rivers (father) and Esther Lanz Garcia (mother). He left Marianao High School in 1947 without graduating. He received private flight instruction at Santa Fe Airport in 1950. Subject had six brothers and two sisters who are listed with their ages: Sergio, 39; Guillermo, 25; Reinaldo, 23; Jorge, 22; Eduardo, 20; Pedro Luis (?); Yolanda, 32; and Esther, 15. They were all listed as being in Havana with the exception of Sergio who was in the United States. Subject described his position as Inspector-General (equivalent to Deputy Commander) of the Cuban Revolutionary Airforce.

3. A usually reliable source reported on 4 August 1959 that Subject was married to Emilia Alvarez Martinez de DIAZ Lanz.

Due to the complications involved in Subject's obtaining a United States visa in 1959, it is believed that additional information concerning Subject may be obtained from the Department of State, Visa Section, and from the Immigration and Naturalization Service. You are also referred to the Federal Bureau of Investigation for voluminous additional information concerning Subject.

5. You are referred to TDCS-3/397,010 disseminated on 27 April 1959, and to TDCS-423,897 disseminated on 8 January, 1960, for further information concerning Subject.

6. The Interagency Source Register contains no record of a current operational interest in Subject.

7. Paragraph 6 confirms telecon of 12 July 1963 between Miss [redacted] and Mrs. Taylor of your office.
