1. FIRST TWICKER/AMHAWK MEETING SINCE LATTER ASSUMED POST OF GENERAL COORDINATOR FOLL PRINCIPLES ESTABLISHED:

A. MINIMUM "INTERFERECE" BY PBPRIMERS IN CUBAN AFFAIRS:

I. E. TWICKER WILL MAINTAIN NORMAL CONTACTS WITH AMHAWK AND OTHER AMCIGAR MEMBERS PLUS SOSA AND PAULA, ALSO HAS RIGHT DISCUSS OPNS WITH DEPARTMENTAL CHIEFS. GUPTON AND ENZEL WILL CONFINE CONTACTS TO DEPARTMENTAL CHIEFS WITH WHOM THEY HAVE VEEN WORKING PLUS SOSA.

B. NO PBPRIMER SHOULD MAKE SPECIFIC COMMITMENTS TO ANY CUBAN WITHOUT PRIOR CONSULTATION WITH AMHAWK. FOR EXAMPLE: NO POST IN AMRASP SHOULD BE PROMISED TO ANY CUBAN WITHOUT AMHAWK AGREEMENT.

C. NO AMCIGAR/AMRASP MEMBER MAY UTILIZE PBPRIME FUNDS FOR HIS PRIVATE POLITICAL ENDS.

D. ANY OPPOSITION GROUP IN CUBA ACCEPTING AMRASP ARMS MUST ACCEPT AMRASP BANNER FOR DURATION OF FIGHT.

2. BELIEVE ABOVE REASONABLE IF AMHAWK AUTHORITY AND AMRASP UNITY TO BE MAINTAINED. HOWEVER IN PRACTIVAL TERMS NONE OF ABOVE INTENDED CURTAIL CURRENT PRODUCTION OR RELATIONSHIPS.
