MEMORANDUM FOR THE RECORD

SUBJECT: Tony VARONA

1. On this date the captioned Subject called the sterile number at the Security Office and requested someone to call him on Ext. 2-0300, Ext. 707 at Washington, D.C.
2. Inasmuch as Mr. [redacted] has been designated as the replacement for Jerry Droller in liaison matters with Miro CARTONA, Mr. Chamberlain was notified relative to the instant call.
3. Upon notification, Mr. [redacted] advised that Tony VARONA was not stipulated as one of the Cubans with whom he should liaison. However, it was suggested to him that he might wish to check the matter out with both Mr. Droller and Col. J. C. King.
