1. ANBANG-1 REPEATED DURING 3/4 JULY MEETING WAVE AREA
 RECENT ANSWIRL-1 ACTION AGAINST JURE RADIO FACILITY. ANBANG-1
 STATED ANSWIRL-1 ASSIGNED WAVE AREA SINCE 56 OR 57 AND HE KNEW
 FRIEND BATISTIANOS. WHILE ANBANG-1 MENTIONED ANSWIRL-1 REPUTATION
 AS BEING PRO-BATISTA, HE CONSIDERED THIS UNIMPORTANT AND NOT
 GERMANE TO ISSUE. THIS ASPECT RAISING ONLY WITH NAUMAN.

2. ANBANG-1 ALLEGES ANSWIRL-1 TOLD JURE REFS IN BOCHE
 AFTER MAKING REFERENCE "THE FAILURE" (ANBANG-1'S RECENT DETECTION)
 THAT MEN SHOULD NOT GIVE UP BUT GET RID THEIR LEADER AND CONTINUE
 FIGHT. ANBANG-1 FELT THAT SO HARM WOULD COME THIS STATEMENT GIVEN
 THAT MEN TO WHOM IT MADE "GOOD MEN." INTENT AND EFFECT OF SUCH A
 STATEMENT BY AN ODYOKE OFFICIAL DOES CONCERN ANBANG-1.

3. NAUMAN TOLD ANBANG-1 THAT AN ODYOKE OFFICIAL SUCH AS
 ANSWIRL-1 WOULD NECESSARILY DEVELOP INFORMATION FROM ALL TYPES
 INCLUDING BATISTIANOS. NAUMAN EXPRESSED DISBELIEF THAT AN ODYOKE
 OFFICIAL, HAVING NOTHING DO POLITICAL POLICY, WOULD MAKE SUCH



STATEMENT. NAUMAN REASSURED AMBANG-1 THAT AMSWIRL WAS CERTAINLY NOT EXPRESSING ODOFOKE VIEWS. IF HE WISHED COULD PURSUE MATTER TO SATISFACTION WITH AMSWIRL-1 SUPERIORS OR ODACID. AMBANG-1 STATED WOULD PROBABLY MENTION MATTER TO ODACID'S LOCAL REP IN MEETING 6 JULY 64.

4. AMBANG-1 ALSO QUESTIONED AMSWIRL-1'S ROLE IN TAKING ACTION ON WHAT IS FCC BUSINESS. NAUMAN STATED DID NOT KNOW DETAILS AMSWIRL-1'S CHARTER BUT THAT HE PROBABLY WORKED UNION ALL LAW ENFORCEMENT AGENCIES.
