ON 2 JULY 1963 [RENE PUJOL] SAID THAT EVELIO DUQUE REPEAT DUQUE MIYAR AND HIS GROUP, THE EJERCITO CUBAN ANTI-COMUNISTA (ECA, ANTI-COMMUNIST CUBAN ARMY), PLANNED TO SET OUT IN SEVERA BOATS, AMONG THEM THE VIOLIN III, FOR ONE OF THE KEYS ON THE NORTHERN COAST OF LAS VILLAS PROVINCE "SOMETIME AFTER THE 8TH OF JULY". ACCORDING TO [PUJOL], WHO WILL CAPTAIN ONE OF THE BOATS, DUQUE INTENDS TO SET UP A BROADCASTING STATION ONCE THE KEY IS SECURED TO INFORM THE CUBAN PEOPLE THAT THEY HAVE ESTABLISHED "FREE TERRITORY" ON CUBAN SOIL.

2. THE TRUE PURPOSE OF THE MISSION, HOWEVER, CONTINUES TO BE DUQUE'S FORMERLY STATED AIM TO EMBARRASS THE UNITED STATES GOVERNMENT AND TO FORCE IT INTO DIRECT ACTION AGAINST CUBA. THROUGH THIS CLANDESTINE RADIO, DUQUE WILL SEEK RECOGNITION FOR HIS "FREE TERRITORY" FROM THE ORGANIZATION OF AMERICAN STATES (OAS) AND FROM THE UNITED NATION (UN), WITH THE HOPE OF PUTTING THE U.S. IN THE MIDDLE. IF DUQUE'S GROUP SEES THAT ITS PETITIONS GAIN NO RESPONSE FROM THE OAS AND THE UN, THE GROUP PLANS TO RETREAT TO THE UNITED STATES. IF THESE PETITIONS SHOULD STIR SOME COMMOTION, HOWEVER, THE GROUP WILL REMAIN AS LONG AS ITS POSITION IS TENABLE.

3. ^{ob}[PUJOL] SAID THAT DUQUE'S GROUP APPEARS TO HAVE AMPLE FINANCIAL AID. ^{ob}[PUJOL] SUSPECTS THE AID COMES DIRECTLY FROM FORMER PRESIDENT FULGENCIO BATISTA. HE BELIEVES THAT DUQUE HAS NO INTENTION OF DOING ANY FIGHTING HIMSELF WITHIN CUBA. WHILE DUQUE ADMITS THAT HIS CONTACTS INSIDE CUBA ARE FEW, ^{ob}[PUJOL] CLAIMS THAT DUQUE HAS NO STOMACH FOR REAL FIGHTING.

4. ^{ob}[PUJOL] SAID THAT IF DUQUE IS SUCCESSFUL IN GETTING HIS "FREE TERRITORY" RECOGNIZED, HE WILL INSIST THAT ALL OF THE REVOLUTIONARY MOVEMENTS IN EX-LE BE CONSTITUTED AS POLITICAL PARTIES AND THAT THEIR RETURN TO A "FREE CUBA" BE AUTHORIZED

5. [PUJOL]⁰⁶ SAID THAT ALTHOUGH HE CANNOT ABIDE DUQUE'S EXTREME ANTI-AMERICAN SENTIMENTS, HE HAS RETURNED TO DUQUE'S SERVICE BECAUSE HE CAN FIND NO OTHER ANTI-CASTRO ACTIVITY IN WHICH TO ENGAGE.
