Recommendations for debriefing of Evilio DUQUE Mijar

1. Complete biographic data (fill out a PRQ or go over his step by step.
2. All political affiliations since 1956 - all organizations to which he belonged or with which he was in sympathy.
3. Outline military and para-military career - organizations - names of superiors - number of subordinates - his activities - his missions and how he accomplished them - his failures - demand specifics.
 - a. Relatives inside Cuba: their past and current political sympathies - were any imprisoned or shot by Batista? by Fidel?
5. Arrest records: by Batista - by Fidel - by original police, as opposed to political or secret police - Crimes he has committed (smuggling, theft, murder, rape, use of narcotics). Has he been blackmailed? Does he know anyone who could blackmail him? Secret crimes? Have any of his relatives or friends been arrested for these crimes?
6. Contacts with Communist Party: members or sympathizers - make distinction between 26th of July Movement and CP. Did he attend CP meetings or 26 July meetings. Does he know any CP members? Was he ever asked to join the Party? Did he ever agree with the aims of the Party?
7. Contacts with Cuban Intelligence Service (DIER-G-2) - ever arrested by them - friends or co-workers arrested by them - did he ever work for them or promise to work for them - betray anyone to them.

It is noted that the LOPLUTTER examiner who examined DUQUE in January 1942 characterized him as possessing limited intelligence, and the examiner had very little background information on him on which to base detailed interrogation. DUQUE's unfavorable reactions in the examination were not explained in any way by the subject, who insisted he was completely truthful. A detailed debriefing should provide the next operator with the essentials for corroboration.
