IT WOULD ENHANCE OUR POSITION WITH OUR [REDACTED] IF WE WERE ABLE TO ANSWER MOST OF THE QUESTIONS WHICH MIGHT ARISE FROM PUBLIC STATEMENTS MADE BY AELADLE EVEN IF THEY CONCERN COUNTRIES AND MATTERS NOT OF IMMEDIATE CONCERN TO WEST GERMANY PER SE.</p> <p>2.
