SUBJ GRANTED ON SEPT 65 FOR USE BY ANOTHER WOMACE COMPONENT BUT ON CANCELLED FEB 66 SINCE SUBJ JUDGED UNSUITABLE FOR PROPOSED [redacted] ASSIGNMENT. IN MARCH 67 WOBISH REQUESTED INERGO APPROVAL TO USE SUBJ AS FI SOURCE. IN VIEW SUBJ'S WOFIRM CONTACTS, HIS FORMER CRC POSITION IN NEW ORLEANS AND HIS CONTACTS WITH CERTAIN INDIVIDUALS INVOLVED BOTH BROWN/SLATTER AND GARRISON INVESTIGATIONS, WOMACE INTERESTED ALL PHASES SUBJ'S PAST WOMACE ACTIVITY.
