Operational security precludes a confrontation of the AMSPELL organization, therefore Headquarters will have to be satisfied with copies of the original documents for some of the import/ export items, and with xeroxed copies of merely the cover sheets for some of the other items

This whole sad story has had one positive reaction. On 24 July 1962 at 1930 hours NOEMAYR and PAPOCK will be visiting the intelligence components of the AMSPELL organization to see what type of information they might have which does not, has not, and probably was not going to be forwarded to NOEWAYR.

Place acquired changed to Cuba to facilitate dissemination.

According_to the DRE the ultimate source is The covering note from the DRE in Cuba to the DRE in exile pointed out that these documents were originals, and that the information in them is available to Dorticos, Fidel, Carlos Rafael Rodriguez and two or three other people. An evaluation of this material would be appreciated from NULYNX.
