WE COMMENT: *Jose Ramon EGUES y Gran a and Jose Emilio AZOT Hernandez, former members Cuban Revolutionary Police who arrived Mexi approx 7 Oct.60 in voluntary exile, trying get Miami to join AMRASP. AmEmbassy HAYA considered EGUES ineligible for visa because he attended police indoctrination course, which Communist. EGUES claims he never attended indoctrination classes which he considered Communist. Station Mexi desires assist them with visas.
