- ON 25 AUG 60 ELOY GUTIERREZ MENOYO, CUBAN NATIONAL DOB 8 DEC 34 MADRID AND RAFAL HERNANDEZ DOB 4 DEC 35, CUBAN DIPLOMAT ARRIVED LISBON BY AIR FROM PARIS. BOTH PROCEEDED SANTA MARIA IN AZORES WHERE REMAINED UNTIL 28 AUG. DEPARTING FOR HAVANA VIA CUBANA AIRLINES. IN SANTA MARIA HAD CONTACTS LINDSEY LING AKA LING LIND SEY, CHINESE. LINDSEY MANAGER CHINESE RESTAURANT, RUA VALAVERDE 9, MADRID. RESTAURANT OWNED BY SECOND CHINESE WHO ALSO HAS BUSINESS SELLING CLOTHING U.S. PERSONNEL LAJES BASE, AZORES. LINDSEY PLANNING GO BERMUDA STUDY SET UP RESTAURANT. THEODOR HEINZ WIENER WHO REPRESENTED ABOVE CLOTHING FIRM AZORES, NOW REPORTEDLY IN BERMUDA.
- ON 26 AUG GUTIERREZ SENT CABLE TO ROGER RODONDO, HAVANA, INFORMING WOULD ARRIVE HAVANA CUBANA FLIGHT.
- COMMENT: GUTIERREZ REPORTEDLY LEADER OF DRIL IN CUBA AND REPORTED IN MADR 16 JULY. WIENER ARRESTED DEC 58 IN AZORES ON SUSPICION ESPIONAGE.
