1. AMPATRIN-1 NOW IN MASH AREA. MET MANSON NIGHT 11 SEP. SAID HE HAD BEEN ASKED BY DONALD HOGAN AND ALBERTO FERNANDEZ TO CONTRIBUTE TO A NEW GROUP KNOWN AS FUND FOR THE RESETTLEMENT OF CUBAN EXILES INC. BASED IN NEW HAVEN CONN AND HEADED BY HOGAN. MANSON QUICKLY DISCOURAGED ANY FINANCIAL ASSISTANCE FROM AMPATRIN-1 TO THIS GROUP.
2. ABOVE REQUEST FOR GUIDANCE FROM AMPATRIN-1 TYPICAL OF MANY DURING PAST MONTHS. MOST HAVE REPRESENTED THEMSELVES NOT BENEFICIAL TO OVERALL JMWOC OBJECTIVES AND MANSON HAS RECOMMENDED AGAINST CONTRIBUTIONS BY AMPATRIN-1. AT SAME TIME IT IS OBVIOUS AMPATRIN-1 AND HIS BUSINESS ASSOCIATES WISH DONATE MONEY WHERE IT CAN DO MOST GOOD.
