1. MICHAEL MALONE, HQS SOURCE NEW YORK, PASSED FOLLOWING REPORT FROM RELIABLE SOURCE MIAMI AREA:  
ONE PATRICIO ESTEVEZ, A CUBAN CITIZEN, EMPLOYED HAVANA OFFICE SON LIFE ASSURANCE CO. (A CANADIAN CORPORATION) WAS RECENTLY RETURNING ON TRIP FROM CUBA AND RETURN.
