He, rather than be harassed with detailed questions about people and places, perhaps he should seek his objectives through normal channels. We are sure the local consulate can instruct him what the normal process would be.

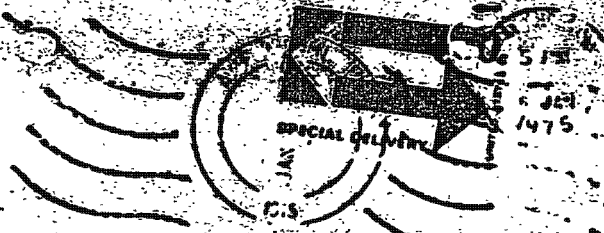
