1. Reference is made to your memorandum of 11 August 1960, your file no. 100-370750, entitled John Howard LANSON, Internal Security - C.
2. According to documentary information dated 11 January and 13 February 1961, acquired from a usually reliable source with access to the information, the Cuban Institute of Motion Picture Arts and Industry has expressed an interest in having John Howard LANSON, a resident of California, go to Cuba as a teacher and writer in the Cuban movie industry. To facilitate LANSON's correspondence with the Institute in Habana he has been given the address of Sofia Garro de TELASCO, Patricia Senz 36, Departamento 6, Mexico 12, D.F., Mexico. His mail will then be given to Teresa PIORNZA Proenza, Cultural Attaché of the Cuban Embassy in Mexico, for forwarding to the institute. This channel for correspondence has also been arranged for Carlton MOSS, whose address is P.O. Box 1627, Hollywood, California. The institute has requested a copy of MOSS' film, "The House on Cedar Hill", or any related documentaries.
3. The above information should not be disseminated outside your Bureau without prior consultation with this Agency.
