Station comments by cable		

1. The senior KUMKU staff has recruited a number of individuals who have had extensive experience in politics, particularly as campaign managers and political organizers. Very recently one of these organizers was sent to [] where he was in contact with the Station and the two principal agents of a political action project. In addition to his conversations with these individuals he also traveled around the area and talked to a number of auditing individuals prior to meeting again with Station personnel and the principal agents. As a result of his conversations and of his delving into the local political scene, he was able to come up with an exceedingly informed assessment of the local political scene as well as specific recommendations in regard to the organization of the political action factions being supported by KUMKU, plus recommendations as to how they should proceed toward meeting their immediate problems, which included the melding of a number of divergent factions into a cohesive organization capable of united action against the Communists at the polls. The Station was pleased with the results almost to the letter in their recommendations to Headquarters.

2. It is Headquarters' feeling that Edward G. TICHBORN, described in Paragraph 4 below, could perform a very useful service in Cuba similar to that which the organizer mentioned above performed in []. If provided with a suitable cover story, TICHBORN could visit intense VAKSHA (who we understand is now recovering from a recent automobile accident), Sanchez Sanchez and other regional and national political leaders. On the basis of his discussions with them he should be able to come up with a number of practical suggestions which could be of value in implementing AMATOL and other future political action projects. Two advantages which an organizer of this type offers to a field station are, first, that he is a specialist in the details of practical politics—a broad and complex field of endeavor—and second, that he talks to fellow politicians as a non-official practitioner of that art and is uninhibited by any overt connection with CDTI.

3. It is proposed, therefore, that TICHBORN be sent to your Station on TIN for 30 days to consult with Station personnel and to talk to VAKSHA, SANCHEZ, and others. We should like to have your comments on this proposal as well as whatever ideas you may have on what cover story TICHBORN could use during his talks with the political leaders involved. It is the belief of Headquarters that, once the initial contacts are established, perhaps through direct introductions by the Station, a natural affinity of interest between TICHBORN and the Cubans will serve to establish rapport quickly. Although the TIN of TICHBORN would be of value chiefly in connection with AMATOL, we would prefer that he be sent immediately, before final project approval.

4. TICHBORN was born in Denver, Colorado, 1920. BA, University of Denver, 1944; Graduate School of Economics, Harvard University, 1944-1945; LLB Harvard Law School, 1946; graduate study, Universidad Nacional de Mexico, 1953. He is a practicing attorney and has had a great deal of political experience. He ran unsuccessfully for a high office on the Democratic ticket in California in 1958. He is a Phi Beta Kappa; was president of the Harvard Law School Forum and has published a number of articles on law and labor. He is an American citizen of Mexican parents, who speaks native Mexican Spanish and has a typical Mexican appearance; he could pass for a Mexican. He has on several occasions visited the

Cuba and at the time of his recruitment exhibited great interest in the situation in Cuba and advised the recruiter what action, if any, GULFIC was taking in Cuba. This was an unqualified inquiry as Cuba had never been mentioned in the course of recruitment. Needless to say, his recruiter made no statement which could indicate any active role on the part of GULFIC.
