MEKI-9443, 18 November 1961      B. DIR-27331, 30 November 1961      C. MEKI-9596, 8 December 1961</p> <p>1. As the Station was informed in reference B, JMZIP wishes to terminate its relationship with AMUPAS/1 effective 1 January 1962 because of agent's loss of access to the target. According to reference C, the Station wishes to continue using AMUPAS/1 to satisfy general needs of the Station. It is therefore requested that effective 1 January 1962, all funds paid AMUPAS/1 be charged to the Mexico City OOA and not to JMZIP. If, prior to 1 January 1962 the Station decides to terminate AMUPAS/1, a bonus of \$100 plus travel expenses to PBPRIME are authorized from JMZIP funds.</p> <p>2. To cover AMUPAS/1's work for the Station, it will be necessary to amend the Q1 and 2 now TEC II should be submitted after cycle A. (Subject has been able to review the operation as stated in paragraph 3 of reference C. The Station might also consider preparing a formal contract. Subject is now under oral contract only.)</p> <p>3. In accordance with the wishes of the Station as expressed in MEKI-9443, and agreed to in a subsequent cable, Headquarters is no longer in contact with AMUPAS/1. There are still some administrative details pending, however, and Headquarters would appreciate the Station having AMUPAS/1 complete the following forms and return them to Headquarters:</p> <p>A. Pseudo/True name acknowledgement forms #SD-359-22A (copy attached)      B. Withholding Exemption Certificate &amp; Questionnaire, Form 313. (copies attached). (Subject verbally agreed to: No exemptions; 187. withholding - 17 July 1961) 24      C.
