You will remember that we were able to provide some advice on precautions against kidnapping to key members of the American Chamber of Commerce which resulted in expressions of gratitude from those who knew the source. (See HMAR-41,286 of 16 November 1971.) Now, KMACETONE-1 tells me, the police of the Distrito Federal have increased patrol activities around some U.S. firms, on the basis of supposed information that there are threats against these firms or that someone plans to "do something" against them.
