1. FOLL FROM RIGAUD WHO ACCOMPANIED EVLUSH-1 TO SANTIAGO FOR SECOND KENSETT MEETING:

A. RIGAUD'S SPIRITS SOMEWHAT HIGHER THAN DURING PREVIOUS MEETING AS HE ANNOUNCED GARRIDO PREPARED TO PROVIDE BLACK AIRSTRIP FOR COMBAT AIR. SITE IS 02 WHICH GARRIDO WILLING PUT IN SHAPE WITH MINIMUM LABOR. VIAS ROMAN WITTING BUT IF SOMEONE BACKFIRES GARRIDO MUST TAKE RAP ALONE. RIGAUD WILL SURVEY WITH COMPASS AND MEASURE WITH VEHICLE 4 SEPT. HE TOLD OYOKE WON'T ASSIST WITH AIR. THAT NO ASSISTANCE TO BE PROVIDED UNTIL EVLUSH-1 MOVES. RIGAUD DISAPPOINTED AT THIS STATING FUTURE BLEAK IN THAT EVLUSH-1 NOT OPTIMISTIC RE FWD GROUPE. CO AGREED STATING GROUPE SET RUMORED TO BE AS BLACK AS MASFERRER. CO ASKED RIGAUD IF MASFERRER INVOLVED WITH BILL JONES IN LOCATING SULLIVAN/RORKE B 25. HE CLAIMED DID NOT BELIEVE SO. HE TOLD SIT TIGHT BOTH DEALS TO ALLOW CO TIME TO CHECK. THAT PERHAPS POSSIBILITIES EXISTED ONE OR BOTH SOURCES. POINT EMPHASIZED THAT OYOKE WOULD NOT ASSIST WITH AIR. HE REPLIED

HE HAD OBVIIVE TOURISM INTERESTS THAT WOULD ADVANCE FUNDS IN EXCESS 3 THOUSAND <sup>02</sup>EVLUSH-1 HAS FOR PURPOSE. PLS ADVISE VIEWS <sup>#</sup> DURING SULLIVAN IF WAFERRER BYPASSED. ALSO LATEST VIEWS RE GROUPE.

B. RIGAUD ANNOUNCED LEON BACK IN FOLD. CO COMPLAINED RE INCONSISTENT REPORTING ON OFFICER SITUATION WHICH RIGAUD ADMITTED AND EXPLAINED HE PERHAPS MISINTERPRETED SIGNS. HE MAINTAINS PHILOGENE, LEROY AND PERHAPS VILLMINEY, ALEXANDER AND DESYANELES WILL GO IT ALONE IF <sup>02</sup>EVLUSH-1 REFUSES MOVE WITHOUT AIR.

C. RIGAUD WILLING INSERT LIAISON OFFICER IF GARRIDO CONCURS. CO RAISED QUESTION LIAISON OFF COVER AND PRIED FOLL OUT OF RIGAUD. GARRIDO SUSPECTS DROP WAS FROM P2PRIMERS AND PERHAPS ODYOKE AS HE REPEATEDLY MENTIONS FACT ODYOKE CANNOT BE OVERTLY INVOLVED IN PROVIDING ASSISTANCE TO EVLUSH-1. RIGAUD REMINDED THAT ODYOKE ROLE MUST NEVER COME OUT REGARDLESS SPECULATION. AFTER MUCH DISCUSSION CO AND RIGAUD AGREED LIAISON SHOULD REPRESENT RIGAUD WHO BECAUSE OF FREQUENT TRAVEL CANNOT MAINTAIN CONTINUITY SITUATION. HE WILL PROPOSE TO GARRIDO AND STALL ON NAMING INDIVIDUAL STATING THERE A NUMBER POSSIBILITIES. (COMMENT: THIS SHOULD HAVE BEEN TOPIC CONVERSATION BETWEEN <sup>02</sup>EVLUSH-1/RIGAUD DURING RETURN DRIVE TO DAJABON.)

D. RIGAUD PLANS DEPART SMO FOR NY 6 SEPT TO ATTEMPT PROCURE AIR. HE INTENDS TRAVEL BACK AND FORTH AS NECESSARY CLAIMING MISTRUST OF <sup>02</sup>EVLUSH-1 AND VERNA WHO IMPULSIVE.

E. CO REQUESTED RIGAUD GET GARRIDO PERMISSION LAUNCH 3-4 MAN NON COMBAT RECON PATROLS INTO TARGET AS REALISTIC TRAINING. RIGAUD FEELS HE CAN SELL.

F. & CO IMPRESSED ON RIGAUD NEEDED FOR FACTUAL INFO.  
POINTING OUT THAT PAST EXAGGERATIONS AND FABRICATIONS HAD WORKED  
TO HIS DISADVANTAGE SINCE KUBARK NOW DOUBTS ALL IT IS TOLD.  
RIGAUD REPLIED HE RECOGNIZED THIS NOW AND WOULD WORK TO REPEL  
DAMAGE DONE.

F. RE LOCAL LIAISON CANDIDATES: STATION NOT IN TOUCH  
WITH ANYONE WORTHY CONSIDERATION. IT PANTLEONE OPINION HQS  
SHOULD SELECT AND BRIEF AN EXPENDABLE TYPE FROM AMONG NY EXILES.  
SUGGEST ROZZAZA BE QUERIED ON SUITABILITY ROLAND RIGAUD. ALSO  
SUGGEST EXPEDITE HANDLING VIEW RIGAUD INTENTION DEPART SMO 6  
SEPT.
