SUBJECT: ROLANDO MASFERRER

1. A USUALLY RELIABLE SOURCE REPORTED THAT ON 8 JANUARY 1963 AN UNTESTED SUBSOURCE TOLD HIM AMERICANS WERE INVOLVED IN A CONSPIRACY INSIDE THE CUBAN GOVERNMENT WHICH MIGHT SOON RESULT IN AN OPEN OUTBREAK.
2. ROLANDO MASFERRER REPORTEDLY HAS 1300 MEN WITH WEAPONS READY, AND WANTS TO SEND THEM TO CUBA AT THE OPPORTUNE MOMENT. HE PLANS TO VISIT MIAMI INCOGNITO THE WEEK OF 14 JANUARY.
3. THE ABOVE INFORMATION IS BEING MADE AVAILABLE TO THE IMMIGRATION AND NATURALIZATION SERVICE, TO THE BUREAU OF CUPTOMS, TO THE BUREAU OF INTERNATIONAL PROGRAMS OF THE DEPARTMENT OF COMMERCE, AND TO THE U. S. COAST GUARD.
