1. FAIRLY RELIABLE SOURCE WHO ATTENDED MEETING MORGAN WITH CUBAN COUNTER-REVOLUTIONARIES REPORTS MEETING HELD HOME DOMENIC E. BARTONE (SIC) 4236 CHASE AVE, MIAMI BEACH, FLA.
2. SAME SOURCE PREVIOUSLY REPORTED MORGAN RECEIVED \$110,000 FROM COUNTER-REVOLUTIONARIES FOR USE AGAINST CASTRO. PUBLIC ACCOUNTS MORGAN OPERATION INDICATE HE RECEIVED ONLY \$75,000.
3. SUM REFERRED TO IN REF PROBABLY DIFFERENCE BETWEEN AMOUNT DECLARED BY MORGAN AND WHAT ACTUALLY PAID HIM.
4. HQS INTERESTED DETERMINING AMOUNT AND WHETHER MORGAN HOLDING OUT ON CASTRO, OR IF MONEY TO BE USED AS SECRET FUND BY CASTRO TO FINANCE OTHER REVOLUTIONARY ACTIONS OR PERSONAL USE.
5. REQUEST SOURCE REF PROVIDE FULL DETAILS ON ACCOUNT AND TRANSACTIONS ON CONTINUING BASIS.
