1. DURING GALBOND TALKS IN NY WITH AIB MAIFER DONNELLY, LATTER STRESSED NEED TO SUPPLY PROGRAMMING TECHNICIAN TO RADIO CARA, BEGINNING AS SOON AS POSSIBLE. DONNELLY CAN MAKE INTRODUCTIONS TO OWNER OF RADIO CARA.
2. SINCE FCB OFFICER WITH THESE TALENTS HAS ARRIVE CARA MID OCT, CURRENT HOLD IS FOR MR. DAVE PHILLIPS TOY CARA POSSIBLY AS EARLY AS WEEK OF 22 SEPT AND TO REMAIN PERHAPS ONE MONTH. NO REASON PHILLIPS ARRIVE CARA BEFORE DONNELLY RETURN THERE. HENCE, PHILLIPS SHOULD NOT DEPART HAYA UNTIL MORG VERIFIES THIS DATE.
3. PARA 1 PHILLIPS CONTRACT BEING AMENDED AS FOLLOWS: "WHILE TRAVELLING OUTSIDE CUBA AT THE REQUEST OF ODYOKE AND ENGAGED FULL TIME IN THE WORK OF ODYOKE, YOU WILL BE COMPENSATED IN AN AMOUNT CALCULATED AT THE RATE OF \$13,000 PER ANNUM, PLUS STANDARD GOVT PER DIEM FOR THE AREA OF TRAVEL OR TEMPORARY RESIDENCE".
