1. CLERK POLICE CONTACT ADVISED CLIFFORD V. CONNELL, AGE 38; HAROLD WHIDDLE, AGE 45; RENE ERNEST BLOH, AGE 36, ARRESTED WAVE AREA FOR THREY 43 CASES DYNAMITE AND ILLEGAL POSSESSION EXPLOSIVES. CONNELL APPEARED JUSTICE PEACE COURT AND CLAIMED STOLE DYNAMITE FROM JOSEPH N. MEROLA, SUBARK AGENT. CONNELL'S TRIAL DATE NOT SET BUT PLANS WAVE DEFENSE TO BE HELD FOR KUBARKER.

2. MEROLA IS NOT KUBARK AGENT BUT USED SOLELY AS INFORMANT BY ~~ARM~~ <sup>JAM</sup> (SEE REF). WAVE HAD NO KNOWLEDGE CONNELL'S ACTIVITIES OR RELATIONS WITH MEROLA IF ANY. MEROLA WAS SUSPECT IN \$300,000 ROBBERY AND UNDER SURVEILLANCE BY GMI/VY.

HOWEVER, DUE TO SUBARK POLICY, KUBARK CANNOT ADMIT OR DELY CONNELL'S CLAIM OF ANY RELATIONS WITH MEROLA. POLICE CONTACT UNDERSTANDS KUBARK POSITION AND ASSURED WAVE THERE COULD BE NO
