DOS- 9 September 1955, Tokyo, Japan. In 1957 he was manager of Maquinas de Comercio S.A. in Ecuador. [Guayaquil] Base wanted operational clearance for him in March 1957. He was used as a cut-out. There was no derogatory information about Richard MOSS.

MOOS, Felix (n.m.i.) (201-242513)

Born: 29 September 1908 in Konstanz, Germany. Was to be used by Station in student activity, 25 August 1958. 13-3

Naturalized U.S. citizen. US Army veteran.

Derogatory information was developed about subject's close associate, Dr. Jack M. MUKI, January 1959. A past supervisor of MOOS was Dr. Frederick S. HULSE, formerly OSS, possibly CP or RIS.

Residence, 1964: 333 Kansas St., Lawrence, Kansas.

FE still wanted to use him in November 1964 to work with ROK veterans, but decided against using him in March 1965. Residence, 1965: Seoul, Korea.

Comment:

A thorough security investigation of this person does not seem to have been made.

He resigned 1 December 1949; he had a serious heart disease.

MOOS, Ernesto Ricardo German (201-55364)

OF Porto Alegre, Brazil (1956) Managing director two firms, EXTRAN, S.A. AND ERMOS, S. A. The two firms are actually the same.

Subject is of Jewish origin, born in Hamburg, Germany, 22 Dec. 1925 and is a naturalized Argentinian. His wife is Edith nee WOLF, born in Hamburg, Germany on 25 July 1930. They have a daughter, Dorothy Viviane, born N.Y. City, who carries a U.S. passport. Subject's and wife's passport show that in the U.S. they visit Elias MOOS, Inc., of 150 Nassau Street, New York City. Legal address of Subject's father, Samuel MOOS, is Avenida 25 de Mayo, Buenos Aires.

He told CIA case officer that he was born in Buenos Aires and had left Argentina after getting into trouble with PERON. --HABA-4520, 11 June 57.

CIA apparently decided subject complete opportunist.

Graduate of Smith College. Has M.A. degree in Slavic literature.

CP member (joined 1937, according to her daughter, Ann)

Affiliated with World Peace Council, National Council of American-Soviet Friendship (member of council's board of directors) and Women's International League for Peace and Freedom.

Residence (1967): 552 Riverside Drive, New York City.

Foreign travel: 1965 was tour guide for a National Guardian tour.)

1963 (France, England, USSR, Poland.)

1967 (USSR, Czechoslovakia, etc.)

Daughter of Elizabeth MOOS. Ann and her mother, Elizabeth MOOS, figured prominently in the case of William W. REMINGTON, former U.S. employec in the Department of Commerce, who died in prison after his conviction of perjury in a security case.

Member, Progressive Labor Movement. Assistant professor of State University of New York, Buffalo, August 1955. --DBB-19845, August 1965.  
Resides at 50 Lerich Drive, Tonawanda, New York. Instructor in Department of Biophysics, School of Medicine, State University of New York, Buffalo. Received a U.S. Public Health Service grant of \$10,000 for "Role of bound nucleotides in muscle contraction, from GEMs" (no explanation of abbreviation).

Eric County CP was trying to find someone without direct CP connections to participate in a committee to defend the CP against the McCarran Act. Subject is son of the head of the Soviet American Friendship Committee. (In 1946 subject's mother, Elizabeth MOOS was Executive Secretary of the Committee on Education, National Council of American-Soviet Friendship.) Paul SPORN was designated by Eric County CP to contact Carl MOOS to see if latter's house could be used as meeting place for persons who were being considered as members of committee to defend the CP against the McCarran Act.

(Paul SPORN was in contact with Mortimer SCHEER on 1 February 1962 re peace demonstration to be held in Cheektowaga, New York.)

Carl MOOS was in contact with Helen and Tobias SCHWARTZ and J. and Paul SPORN several times to discuss "peace" matters. November 61 - June 62. --DBB-19845, 27 April 1965.

Carl MOOS is also known as Robert Moos IMANDE. He left Buffalo to attend medical conference in Japan, late August 1965. Returned 17 September 1965. MOOS made his travel arrangements through Cleary Chase Travel, Inc. He wanted to attend the 23rd Congress of the International Physiological Congress in early September 1965 in Tokyo. Itinerary shown. --DBB-26171, 13 October 65.

Association by Carl MOOS and his wife, Joan, with Tobias and Helen SCHWARTZ, Paul and J. SPORN, October 1962, November 1962, February 1963, May 1963, June 1963, August 1963, September 1963. (Paul SPORN was former Educational director of Eric County CP. In fall 1961, he and other Eric County CP leaders were in factional dispute with National and N.Y. District CP leadership which resulted in a split from the CP in late 1961. Subsequently, he was active in formation of a new Marxist-Leninist Party, referred to in Buffalo as the Progressive Labor Movement (PLM). Carl and Joan MOOS paid dues and contributed to PLM, 1962, 1963. Carl MOOS was treasurer of Buffalo Chapter of SAIE, November 1962.

Meeting held at Carl MOOS' home on evening of 23 October 1962 to discuss speech of President Kennedy regarding the Cuban crisis.

Carl MOOS was involved in several "peace" demonstrations October 1962 - May 1963. WWP and PLM to collaborate in planning leaflet distribution protecting U.S. policy re Cuba. In May 1963 Carl and Joan MOOS bore brunt of work in leaflet preparations. ---DBB-19950, 20 November 1963.
