CONRO CASTLE PRISON IN GEORGIA, MURDER KATON, A ONE TIME LEADING FIGURE

IN THE CASTRO REGIME NOW IN PRISON, WAS TRANSFERRED FROM THE PRISON ON

THE ISLE OF PINES TO LA SABANA FORTRESS. SHORTLY BEFORE THIS TRANSFER,

THE ENTIRE GUARD FORCE AT LA SABANA WAS CHANGED AND DOUBLED IN SIZE.

EACH MEMBER OF THE

REGULAR MILITARY GUARD

FORCE NOW ON DUTY THERE IS

ACCOMPANIED BY ONE OR MORE MEMBERS OF THE MILITIA.
