 2. CHIRAS SAID THAT ESTIVEZ HAD RECEIVED IN MEX EARLIER THIS MORNING NEWS FROM GURA THAT CONTACT WITH SIDONIO WALSH GROUP NOT YET MADE AND THIS ARRANGEMENTS FOR RECEPTION HANGAR NOT COMPLETED. HQS WORRIES WHETHER THIS NOT POLITICAL RAY MANEUVER DESIGNED WEAKEN ARMY FROM ANPAKIC-5 CONTACT OVER EQUIPMENT.
